Prior to his time at Goldman Sachs, Mr. Gauthier was a Managing Director at Conning Asset Management, where he oversaw the property-casualty asset management practice.

Mr. Gauthier has spent almost 30 years at the intersection of the insurance and asset management businesses. He has been a frequent speaker at industry conferences and has represented companies in front of regulators, rating agencies, stock analysts, and shareholders. He has also authored several articles in various insurance and risk management publications.

In addition to running his own investment consulting company, JIG Advisory, LLC., Mr. Gauthier currently sits on several Boards of Directors. He received a Bachelor of Science from Quinnipiac University and an MBA from the Wharton School at the University of Pennsylvania.
